The PTA board for the 2010-2011 year consists of Mary Gorsuch (president), Beth Luevano (vice president), Carla Cogburn (vice president), Diana Nikkari (secretary), and Sue Richards (treasurer). Sue Richards has replaced Kim Holman as treasurer.

Tressa presented a funds request for the Colorado history book entitled "Discover Colorado." The cost for 100 books and 4 teacher guides is approximately \$3,700. This purchase would be for all of the fourth grade classes, assuming those teachers want to switch to this new textbook. Tressa will submit a written request after talking to the other 4th grade teachers.

Mary noted that two funds requests have been received: Patty Deters is requesting the purchase of chess sets for the chess club and Nursing Services is requesting the purchase of a second cot to meet health standards. The board will consider these requests at its next board meeting.
